Membership Agreement

- I understand that the YVR AEROFIT Gym is an unsupervised facility and I agree to use the facility and all the equipment therein, with care and attention.
- I understand that AEROFIT reserves the right to monitor the Gym, through whatever means necessary, in order to maintain a Safe and Secure environment for its Members.
- I understand that none of the equipment is to be removed from the AEROFIT facility and that any such movement (without prior written consent) will be considered property theft.
- I understand that any willful damage to Air Canada or AEROFIT property will be reported to Corporate Security and may result in increased Membership Fees.
- I understand that AEROFIT is sponsored by the Air Canada Recreation Association (ACRA) and that Membership is *mandatory*. By joining, using or entering the Gym, I agree to all ACRA Membership terms. Current members (on Air Canada's payroll) will have the \$12 dues payroll deducted in October/November 2011. Membership cancellation requests must be submitted in writing to ACRA YVR3297 prior to September 1, 2012.
- I understand that AEROFIT has the right to suspend my membership if I aid in admitting non-current gym members into the facility. Members are restricted to Air Canada employees and employees of a tenant in the YVR Operations Centre.
- I understand that AEROFIT reserves the right to review and adjust its Membership fees on an annual basis.

Release and Waiver of Liability

For and in consideration of the use of the Air Canada Recreation Associations' YVR AEROFIT Gym (here after referred to as AEROFIT) the undersigned and my heirs, executors, administrators, and assigns, hereby release, waive and forever discharge AEROFIT, Air Canada Recreation Association, Air Canada and their affiliate and subsidiary corporations and their respective Directors, Officers, Employees, Agents and Servants (collectively the "Release") from any and all liabilities, costs, expenses, claims and the right to claim (of any nature whatsoever) including those that arise out of the negligence of the Release and that I, the undersigned, may have against the Release, in connection with or arising out of the use of AEROFIT or any equipment or attendance of any fitness classes therein, by the undersigned.
